- 1. How to instruct a Remitting Bank to remit funds to your account with our Bank
- Please instruct the Remitting Bank to send a detailed payment instruction in SWIFT MT103 or MX Pacs.008 format to us using the below SWIFT BIC of NCB.
- To designate NCB as the Beneficiary's bank, please provide below details.

- If a remittance is received in a currency different from the beneficiary account, it will be converted into the account currency at our spot rate.
- If you intend to deposit the remittance
 - in Hong Kong Dollar, please provide the remitter with an account in Hong Kong Dollar for setting up the payment instruction.
 - in the remittance currency, please provide the remitter with a Multi-Currency Account or an account in the remittance currency for setting up the payment instruction.
